## 2010 YEAR IN REVIEW

The Foundation continues to support innovative translational prostate cancer research around the country. In a separate publication, you will find the status reports on:

By design, translational research is intended to translate the results achieved from the research bench to patient. This is frequently referred to as bench to bedside research. All of the Foundation's funded research projects are translational and would likely not have been funded by any other source at this early stage. Two of the principal investigators have been able to leverage the four year funding we provided to secure larger grants from other foundations. Dr. Sam Gambhir, Head of Nuclear Medicine and principal investigator of the Stanford research project, calls his work "theranostics"; combining diagnostics with therapy to treat cancer at the cellular level. His research is being generously funded by one family in Los Angeles and has direct applicability to several soft tissue cancers.

In addition to its research, the Foundation is actively seeking ways to inform the public debate and influence public policy on treatment management of prostate cancer. It has been widely reported in the press that

prostate cancer is over-treated in the US. This is due, in part, to the lack of information that men have regarding treatment options available to them today. It is also due to the way the Federal government determines physician compensation standards for various treatment protocols.

The Foundation adheres to a disciplined process of sourcing, vetting, funding and tracking significant, promising research opportunities meeting specific strategic criteria. As a result of our "Best-in-Class" model, we are fortunate to work closely with an exceptionally talented group of physicians, scientists and researchers at leading institutions. Collaboration is the fifth component of our model, both at the micro level in combining Duke and UNC, and at the macro level in assembling the leading international prostate researchers for the Peter Michael Pelican Prostate Colloquium last year.

The Peter Michael Foundation and the Pelican Cancer Foundation, Sir Peter's UK charity, co-sponsored the bi-annual Prostate Cancer Colloquium in mid-2010 in New York. Organized and co-chaired by Dr. Hedvig Hricak, Chief of Radiology, and Dr. Peter Scardino, Chief of Surgery, at Memorial Sloan-Kettering Cancer Center, it was an international discussion that brought together, as one medical journalist said, the "rock stars" of prostate cancer.

The Colloquium was unique in many respects. Most meetings of this type are attended by medical practitioners and researchers in the same field. But our gathering was truly interdisciplinary in scope and attracted an international assemblage of researchers from radiology, urology, oncology and hematology. They were given two subjects - Active Surveillance

To answer the inevitable, as a woman, you have 0% chance of being diagnosed with prostate cancer, so why give PMF your time and energy? It’s simple. First the relationship just ‘happened’, but also, I have two sons, two brothers, and a father. And selfishly, PMF is a great organization that makes me feel like a part of their team/family and being directly involved.

I realize the small things that I do really matter and make a difference on a potentially global scale, through funding of research which is not restricted by government funded guidelines. We are able to follow science where it leads to discoveries like water following the contours of the land – not science that is restricted by imposed boundaries and

impediments. I see the results of programs we fund in real time through direct contact with the doctors and researchers doing the work. The reward of knowing in some small way, some of the things I have the opportunity and privilege of doing through the Foundation, may make something potentially big happen to improve the quality of life for so many, is the ultimate reward.”

and Focal Therapies - and asked to come to a collective point-of-view on the role of both in current prostate cancer management. The dialog between the disciplines and across the continents has been intense as they move each other forward to the final written consensus paper that will be issued shortly.

Another direct result of the Colloquium has the potential to have a profound effect on the treatment of prostate cancer in the very near term. There has been much written about the overtreatment of prostate cancer among US men and its associated economic and human costs. The Colloquium attendees recommended clinical trials to evaluate active surveillance, various focal therapies and radical prostatectomy. However, in reality, that would take twenty years and require tens of millions of dollars.

An alternative was proposed that would employ the use of quantitative decision modeling and meta-analysis of existing data to evaluate the relative costs and benefits of active surveillance, radiation therapies, and prostatectomy. The results of the meta-analysis can then be used to help shape protocols and physician payment practices as governed by the Centers for Medicare & Medicaid Services. This important project will cost \$500,000 and take two years to complete. But it offers the very real opportunity to make less costly, less invasive, more organ sparing prostate cancer treatments widely available to US men. 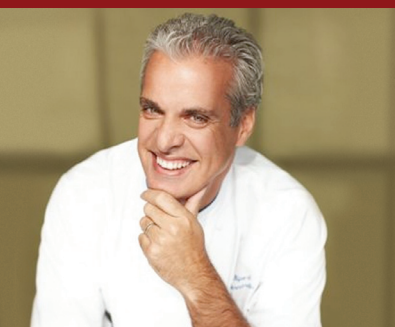
